### Who Should Attend

Industry practitioners who are 25 years old or above, with 3 years of relevant experience at supervisory level or above, or those with RPL qualifications for the logistics industry at QF level 3 or above.

Language requirements:

- Level 2 or above in HKDSE English Language; or
- E or above in HKCEE English Language (Syllabus B); or
- C or above in HKCEE English Language (Syllabus A); or
- E or above in HKALE (AS-Level) Use of English.

Those who do not meet the above language requirements will be required to pass an English language proficiency test prior to admission.
