The AGM included presentations by two guest speakers on important industry issues. Executive Director, Corporate Development of the Airport Authority Hong Kong, Mr. Wilson Fung, spoke on the subject of 'Before the Third Runway', addressing the issues of dealing with over-capacity before the completion of the new runway in 2024. Hang Seng Management College Associate Professor of the Department of Supply Chain, and Information Manager and Director of the Policy Research Institute of Global Supply Chain, Dr. Stephen Ng shared his insights on 'Logistics and Trade Facilitation in the Greater Bay Area", a highly topical subject and one discussed at length during the recent Boao Forum.

Each HAFFA Executive Committee serves a two-year term, an initiative introduced in 2011 to ensure continuity in implementing the Association's vision and policy, and to optimize HAFFA's manpower and resources. The next HAFFA election will be held in 2019 for the 2019/2021 term.
