### **HAFFA/HKSC Joint Logistics Delegation to Qianhai 深圳前海物流考察團**

HAFFA in collaboration with the Hong Kong Shippers' Council (HKSC 香港付貨人委員會) have organized a logistics delegation to Qianhai on 27 October 2016.

Logistics industry is one of the key industries of the Qianhai Shenzhen -Hong Kong Modern Service Industry Cooperation Zone ("Qianhai Cooperation Zone"). The objective of the delegation was to provide opportunities for the delegates to gain a better understanding on the policy and latest development of the freight and logistics industry in Qianhai Cooperation Zone. It also served as a good platform for Members to explore business opportunity in the Mainland.





Led by Mr. Danny Wong (HAFFA Vice Chairman cum Greater China Affairs Sub-committee Chairman) and Mr. Sunny Ho (Executive Director of HKSC), the 40-member delegation visited Qianhai Exhibition Hall (前海展示廳), Chow Tai Fook Global Goods Shopping Centre (周大福全球商品購物中心), Q-Emporia - China Merchants Group (招商自貿商城), CR-Vanguard 'ewj shop' (華潤E萬家), Sea Transportation Centre

- Qianhai Bay Bonded Port Area (海運中心 - 前海灣保稅港區) and import warehouse of CR-Vanguard 'ewj shop' at Globex (華潤E萬家在保宏的進口倉庫).

They also gained the opportunity to meet the representatives of the Guangdong FTA Qianhai Shekou Administrative Committee and Globex e-Services Ltd to obtain information of how to make use of Qianhai's policy to provide more diversified modern logistics services like cross border e-commerce and sharpen their overall competitive edge.
