## **Hong Kong Competition Ordinance**

The Competition Ordnance was passed in June 2012 by the Legislative Council but has not yet come into full effect. As reported before, Members may recall that HAFFA has issued three letters regarding industry's views and many questions on the Ordnance to the Government back in 2008, 2010 and 2011 respectively. However, except an acknowledgment letter, no official feedback to the enquiries was received from the Government.

To better understand the latest development of the Ordinance and its impact on our industry and Members, the Competition Commission was invited for a face-to-face meeting with HAFFA Executive Committee on 31 July 2014. You may wish to know that the Ordinance is designed to be implemented in phases to allow businesses and the people of Hong Kong to become familiar with the new legal requirements, and make necessary adjustments to their business practices.

## Competition Ordinance ABC - THE FOUR DON'TS



To this end, the Commission is tasked by the Ordinance to develop Guidelines to provide guidance and assistance for businesses before the Ordinance is fully implemented. On 09 October 2014, the Commission and the Communications Authority (*CA*) jointly published drafts of the six Guidelines that are required by the Ordinance for public consultation. The Draft Guidelines outline how the Commission and CA expect to interpret and give effect to the three competition rules under the Ordinance (*the First and Second Conduct Rules and the Merger Rule*), as well as the procedures for handling complaints, conducting investigations and considering applications for exclusions and exemptions.

currently on the website for Members' reference. **Member should take note and ensure that no reference** to the HAFFA Standard Trading Conditions (*December 1997 Edition*) is made in your business communications and quotations.
